PRICE INCREASE

Effective April 3, 2013, the month-to-month price of Business Local Calling (BLC) Unlimited A, Unlimited B, Block of Time and Measured packages will increase. BLC Unlimited A will increase from \$42 to \$46.20, BLC Unlimited B will increase from \$37 to \$40.70, BLC Block of Time will increase from \$36 to \$39.60 and BLC Measured will increase from \$33 to \$36.30.
